Good Morning,

Prince Hall Masonic Family of Kentucky that foundation belongs to us. The foundation has been laid. Everyone should do their part for the foundation to help make it a success. For years all I"ve heard was if we had we could do, if we had we could receive, well now we have, it's functioning and it's providing. But the foundation can do more with our help. I'm going to continue with something that PGM Pink J. Garner started a few years ago asking each member that received a tiger coin from him to donate one dollar a week which equals \$52.00 a year to the foundation. I am also asking each cabinet member and each appointed member and each lodge to donate \$52.00.

This year I will give a Grand Masters Achievement Award to deserving members. That award is solely based on the Grand Masters observation and knowledge of a member's compassion, knowledge and work within this organization. This year we will award a lodge of the year, master mason of the year and a deputy of the year. These awards will be given at grand session. You will receive the criteria for these awards.

The 150<sup>th</sup> Year Anniversary: The formation of the Grand Lodge by Mt. Moriah Lodge No.1, St. Thomas No.2 and Meriwether Lodge No.3 is upon us. A 150 year Anniversary for the Grand Lodge will only come around once in a lifetime while you are living. You have heard the Deputy Grand Master talk about some of the things that will go in throughout the year. I am asking you the members please participate, get on the committee, and bring forth some ideas forward. Let's make sure that we have a grand celebration for this grand occasion.

Amnesty Program: Recently I sent out a letter outlining the specifics of the program. From August to December 31, reinstatement for any member is only \$50.00. The lodge keeps the \$50.00. The lodge is not responsible for paying any assessments on that reinstated member until January, 2017. The secretary's of the lodges are responsible for going back 5 years of members that were dropped

and notify them about this program. This program has a dual purpose. If the lodges are able to get members to reinstate it will serve as a mini fundraiser and it will increase the overall membership of this organization. Now the deputies will be responsible for tracking the numbers. So please when they contact you give them what they ask for.

Midwest Regional Conference of Grand Masters & Masons, Grand Chapters and Eastern Stars held in Indianapolis, IN on March 16 - 19, 2017. More information will be forth coming once the MWPHGL of Indiana has the forms finalized. The Grand Worthy Matron and I would like for the members of Kentucky to attend and show your support.

Grand Master Invite and Souvenir Journal: Our constitution states to invite the Grand Master to an official function he must receive an official letter 60 days prior to the function. Email is not an official way of communication. An invitation received via email will only be accepted on if it has an official letter attached to it. If you have a function and have a souvenir journal there should be an ad from the Grand Master included. Upon request the Grand Secretary will provide an ad for your souvenir journal.

Correspondence: Reg. 94 states that secretaries SHALL read all official communications from the Grand Master and Grand Secretary in open lodge, promptly responding, always giving the name and post office of the lodge.

Leadership Training Academy: To improve the Masonic knowledge of our current and future leaders it is a must that we have a leadership training academy. The members and the officers should know the workings of the lodge. They should know when the assessments are due, they should know how much they pay per quarter for each member, they should know how to properly carry a motion and they should know every elected and appointed officers responsibilities. It is hard to watch some of our leaders travel all the way the EAST and they have any more knowledge then they had when they began their journey.

I will close with this. Everyone that is a member of this organization has some work to do. If you want the overall attitudes of the members to be better, we have some work to do. If you want public perception of the organization to improve we have some work to do and if you want the respectability and creditability to improve we have some work to do and more importantly if you want your light to shine so brightly on this organization we have some work to do.
