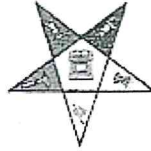


Social Media Policy Effective: March 1, 2016
